## ROAD TRAFFIC REGULATION ACT 1984

## THE BOROUGH OF DACORUM (BANK COURT, HEMEL HEMPSTEAD) (PEDESTRIAN ZONE) ORDER 2014

Dacorum Borough Council, pursuant to the arrangements made under Section 19 of the Local Government Act 2000 with The Hertfordshire County Council in exercise of their powers under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984, (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

- 1. (1) This Order may be cited as "The Borough of Dacorum (Bank Court, Hemel Hempstead) (Pedestrian Zone) Order 2014" and shall come into operation on....
  - (2) In this Order –

    "Pedestrian Zone Restricted Area" means those lengths of road specified below as shown on plan no 1-BC01 and indicated by shading as the restricted area on that plan.
    - (a) Bank Court between its junction with Waterhouse Street and a point in line with the west facia walls of no's 10 and 9 Bank Court.
    - (b) Bank Court between its junction with Marlowes and a point in line with the west facia walls of no's 10 and 9 Bank Court.

'permit holder' has the meaning as any vehicle displaying the Hemel Hempstead Town Centre Pedestrianisation Vehicle Permit authorised and issued by Dacorum Borough Council to have vehicular access to that part of Bank Court specified in Article 1(2)(a) above.

- (3) "Pedestrian Zone Restricted Area Plan" means plan number 1-BC01 which is incorporated into this Order.
- 2. Save as provided in Article 3 to this Order no person shall cause or permit any vehicle to enter or be in those lengths of Bank Court, Hemel Hempstead as defined within Article 1 to this Order as the Pedestrian Zone Restricted Area and as shown by shading on the Pedestrian Zone Restricted Area Plan which is incorporated into this Order.
- 3. Nothing in Article 2 of this Order applies in relation to
  - (a) any Permit Holders vehicle entering that part of the restricted area specified in Article 1(2)(a) of this Order from Waterhouse Street for the purpose of access to premises located within the restricted area and on which is displayed in the relevant position a valid Pedestrianisation Vehicle Permit, issued by Dacorum Borough Council.
  - (b) a vehicle being used for Fire and Rescue, Ambulance or Police purposes during the course of an emergency.
  - (c) anything done with the permission of or at the direction of a Police Constable in uniform
- 4. The Dacorum Borough Council in making this Order are satisfied that this Order is required to avoid the likelihood of danger to persons using those lengths of road specified in Article 1(2) of this Order.
- 5. The provisions of the following Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order;
  - The Dacorum Borough Council (Bank Court, Hemel Hempstead) (Disabled Persons Parking Places) Order 2004
