BACKGROUND

1 Introduction

- 1.1 Providing a full assessment for all the Conservation Areas (23 in all) within Dacorum forms part of the Council's Conservation Strategy. Conservation Area Appraisals have now been provided for Aldbury, Bovingdon, Chipperfield, Frithsden, Great Gaddesden and Nettleden. A Draft Appraisal has been produced for Berkhamsted.
- 1.2 The Strategy includes a programme for the review and production of Conservation Area Character Assessments for all 23 Conservation Areas. The provision of this Conservation Area Character Assessment for Hemel Hempstead is also part of the Council's Heritage Improvement Study. The Conservation Area Appraisal as part of the Heritage Improvement Study supports the objectives of the Hemel Hempstead Town Centre Masterplan.
- 1.3 The Conservation Area Appraisal highlights the special qualities and features that underpin Hemel Hempstead's character and justify its designation. Guidelines provided in the Management Proposals are designed to prevent harm and encourage enhancement. This type of assessment conforms to English Heritage Guidance and to Government advice in the National Planning Policy Framework. It also supports and amplifies those policies aimed at protecting the overall character of conservation areas and forming part of Dacorum Borough Council's Local Planning Framework. The document includes proposals for reviewing the boundaries of the Conservation Area, the current list of buildings of special architectural or historical interest and for providing a list of locally listed buildings.

2 Consultation Arrangements

- 2.1 The Planning and Regeneration Portfolio Holder agreed the draft Character Appraisal for consultation on 6 September 2012 (PH/025/12).
- 2.2 The formal consultation period covered a four week period from 30th April—25th May 2012.
 - Copies of the draft character appraisal were distributed to relevant officers within the Borough and County Councils, and notification letters sent to other appropriate organisations (see list of consultees).
 - The draft document could be viewed on Dacorum Borough Council's website www.dacorum.gov.uk, at the Council's offices at the Civic Centres in Hemel Hempstead and Berkhamsted and at Victoria Hall, Tring.
 - A formal notice was placed in The Gazette.
 - Two public exhibition days were held in Hemel Hempstead on 3rd and 5th May 2012.

3 Key Points

3.1 Boundaries – Two small extensions to the Conservation Area (p.74) have been added:

Extension 1: Area to rear of Nos 75 to 85 High Street (east side) including Nos 9, 10 & 11 Sun Square

Extension 2: Area to the rear of Nos 41 to 51 High Street (east side), including sections of footpath (formerly highway)

The Draft document originally proposed to reduce the size of the conservation area by amending the boundary to the north and north-east of No. 111 High Street, but as a result of the consultation it was considered that the Conservation Area should not be reduced in size.

3.2 Locally Listed Buildings: Appendix 2 (p.81) proposes several buildings for inclusion. Full descriptions have been included for these buildings – owners will be invited to comment on the accuracy of the descriptions.

4 Number and Nature of Responses Received

20 written comments were received.

The qualitative representations and the Council's responses are set out in Annex 1. This includes a full list of these representations, the intended response to the issues raised and recommended changes to the Character Appraisal and Management Proposals.

5 Summary of Changes resulting from Consultation

Amend text to include specific reference to Walled Gardens and Charter Tower in section 10C (p.77)

Amend text to reflect concerns to ensure the closing in of the Cloistered Area of the Town Hall is carried out sympathetically.(p.38)

Update references in text to the Core Strategy and other current Council Documents

Consult with the owners of the locally listed buildings on the accuracy of the descriptions provided in Appendix 2 and incorporate suggested changes where appropriate.

6 Next Steps

- 6.1 Officers recommend the adoption of the draft Hemel Hempstead Character Appraisal & Management Proposals (published for consultation) incorporating the amendments and reviews referred to above.
- 6.2 The adopted Appraisal & Management Proposals will provide additional guidance to the Core Strategy (2006-2031) and thus become an important material consideration in all relevant planning applications. The weight attached to the Character Appraisal is greater because of the consultation carried out and consideration of the comments received. It is now important for the draft Appraisal & Management Proposals to be revised as indicated in this Report and published as soon as possible, together with a statement of the public consultation.
