<b>Purpose of report:</b>	To seek the approval of Council to the co-option of the Parish and Town Council representatives to the Standards Committee.

Appoints Councillor Iain Crawford of Markyate Parish Council as the non-voting co-opted representative of the Parish Councils on the Standards Committee for a term not exceeding the date of the next ordinary election of the Borough Council.</li> <li>2. Appoints Councillor Gerald Wilkins of Tring Town Council as the non-voting co-opted representative of the Town Councils on the Standards Committee for a term not exceeding the date of the next ordinary election of the Borough Council.</li> </ol>

## BACKGROUND REPORT

### Co-opted Parish and Town Council Representatives

1. The Council's Constitution states that the Standards Committee shall include two co-opted Town or Parish Councillors with no voting rights. The Constitution also states that the co-opted Parish and Town representatives cannot also be members of the Borough Council. The terms of office of the previous Town and Parish representatives have expired and both positions are therefore vacant. The Monitoring Officer has contacted all the Parish and Town Councils and Cllr Iain Crawford (Markyate Parish Council) and Cllr Gerald Wilkins (Tring Town Council) have been nominated for co-option.
2. Cllr Crawford has a professional background in education and hospitality and is a former school governor. He has been a parish councillor since April 2007 and has been the vice-chair of Markyate Parish Council since May 2011. Cllr Wilkins is a retired building contractor and farmer and has lived in the Tring and Wigginton area for 50 years. He was elected as a Tring Town Councillor in May 2015.
3. It is therefore recommended that both Cllr Crawford and Cllr Wilkins are appointed as the non-voting co-opted representatives of the Parish and Town Councils for a term not exceeding the date of the next ordinary election of the Borough Council.
