Following on from our conversation at the Health in Dacorum meeting on 31 October, I just wanted to update you on likely timescales for the new Marlowes Health and Wellbeing Centre. This is the building on the other side of the road from the Forum which is currently being refurbished. We spoke about this to members briefly at the 31 October meeting.

We are expecting to have full access to the building granted to us by the end of January, and services will then start to move into the building during March. I note that in this municipal year the next Health in Dacorum meeting is 7 March. We did talk in October about members having a tour of the new facility before it is operational. Would you like to consider doing this prior to the 7 March meeting? As an alternative, we may be able to host the meeting for you in the centre. Do let me know what you think. We have an internal meeting about the centre on Monday and I will raise the issue then as well. Also for you to consider, we will be holding an official opening in May, which we would like to invite members to. I will come back to you about that as soon as possible.
