#### COUNCIL TAX 2020/21

#### **BACKGROUND REPORT**

#### Summary

- 1. This report sets out the statutory information and recommendations necessary to determine the Council's Council Tax requirement for 2020/21, based on the Cabinet's recommendations from its meeting on 11 February 2020, which have been referred to Council for approval on this agenda.
- 2. In approving the budget for 2020/21 Members will be aware that they were required to have regard to the report of the Chief Finance Officer (as included in agenda item 7 for the Cabinet meeting of 11 February 2020, specifically appendix M of the report) when making a decision.
- 3. The Council's Council Tax requirement includes precepts from parishes. The Council Tax resolutions incorporate the parish precepts and those of the County Council and the Police and Crime Commissioner.

#### **Council Tax Requirement**

4. The Corporate Director (Finance and Operations) incorporated within the budget report to Cabinet a statement in compliance with the requirements of the Local Government Act 2003. This requires the Chief Finance Officer (in the Council's case, the Corporate Director (Finance and Operations)) to report on a) the robustness of the estimates made for the purpose of budget calculations and b) the adequacy of the proposed financial reserves. 5. The Council's Council Tax Requirement is £13,057,819.03 as follows:

#### **Council Tax Recommendations**

- 6. The statutory Council Tax calculations require the above amount to include the Revenue Support Grant, the retained Business Rates (collectively referred to as Baseline funding) and any surplus or deficit on the Collection Fund. The result is set as the Council Tax requirement and is divided by the Council Tax base to determine the "basic amount" of the Council Tax for the year. At its meeting on 10 December 2019 Cabinet determined the Council Tax base (after collection rate adjustment of 99.4%) as 58,567.4 together with the amount for each parish. As this includes parish precepts (referred to as "special items"), these are then deducted (expressed as a Council Tax amount) from the "basic amount" to show the amount of Council Tax in any area where there is no parish precept (Hemel Hempstead only).
- 7. The amount of Council Tax in each parish (that is the total of the Council's amount and the parish amount) is then shown.
- 8. The Council Tax bill for 2020/21 includes the requirements of Hertfordshire County Council and the Hertfordshire Police and Crime Commissioner which are responsible for setting their own Council Tax levels. The amount of the precepts from the County Council and the Police and Crime Commissioner for each Council Tax "band" (A to H) are then noted and the final total amount for each parish is then shown by each band (Table 3).

#### Precepts

- 9. Hertfordshire County Council determined its Council Tax requirement at a meeting held on 25 February 2020, at which a council tax increase of 1.99% and a Social Care Precept of 2% was agreed.
- 10. The Police and Crime Commissioner determined its Council Tax requirement at a meeting held on 6<sup>th</sup> February 2020, at which an increase of 5.32% was agreed.
