

'Value For Money Implications'	The project seeks to increase sports participation in the 14+ age group. In Dacorum we aim to use sport as a mechanism for dealing with some of the social problems that we have in a holistic way.			
	£45,000 from DBC and £17,500 from Sportspace will provide the cash contribution needed to release £250,000 from Sport England and £77,500 of in-kind contributions from local voluntary sector groups. The total project cost over three year is £390,000 (including in-kind support) and will cater for approximately 2,500 residents in Dacorum aged 14+ over a three year period. This engagement is sustained			

	engagement which aims to change the behaviour of participants, builds skills in the community and and build the infrastructure within the community to ensure that the projects last beyond the life of the funding. Increased physically activity leads to improved mental and physical wellbeing and therefore can contribute to a reduction in the need for other support services.

The Community Sport Activation Fund is a £40m revenue fund from Sport England which will:

- Enable people to create a sporting habit for life.
- Help stimulate local sports delivery.
- Provide a flexible investment at a very local level.

The fund aims to:

- Increase once a week participation in sport by those aged 14 and above.
- Encourage and support local partners to work together to develop new approaches to delivery.
- Invest in projects that will deliver sustainable increases in participation.
- Support communities across England to help ensure sport becomes a regular part of the majority of people's lives.

Report of Dacorum Borough Council Representative on Hertfordshire Health Scrutiny Committee for Health in Dacorum Committee Meeting of 9th March 2016

The meeting of 16th December 2015 was attended by Cllr Jan Maddern substituting for the regular representative.

At the meeting of 21st January 2016 there was an update on the East of England Ambulance Service Trust (EEAST). Approximately 70 student paramedics have been recruited and continual recruitment is taking place but it takes 3 years to qualify as a paramedic.

For some years clinicians (paramedics, GPs and nurses) have been in control rooms to assist in triage, and it has been decided to greatly increase their numbers.

Concerns were raised by Committee members about missed targets for response times. It was stated by EEAST that if an ambulance arrives within the target time with a less qualified crew, and the wrong equipment and drugs it is classed as a "success". However if the ambulance arrives just outside the target time, but with well-qualified staff and the right equipment and drugs it is classed as a "failure".

It was asked what was the single reason for not meeting response times. The reply was that all ambulance trusts are under the R2 target (8 minute response time 75% of the time for potentially life threatening conditions eg stroke). The EEAST representative questioned whether the target was appropriate and said that more ambulances would be needed to meet targets.

Delays of transfer at hospitals is an issue but EEAST is working with acute hospitals in Herts and Beds to address this issue.

If the 111 service deems a patient to have a potentially life-threatening condition, the computer automatically passes the case to the ambulance service. Herts is below that national target of 9% of 111 calls being referred to the ambulance service. In Herts and Beds, 48% of calls that EEAST attend do not result in a patient being conveyed to hospital.

There are still first responders, trained lay volunteers who can be phoned or texted in the case of a cardiac arrest or other emergency where a patient needs treatment very quickly.

Satnavs on ambulances are as up-to-date as possible. If 999 is phoned from a landline, the location automatically goes to the ambulance and is uploaded onto the satnav.

The health budgets and quality of care (Francis) scrutiny café will take place over two days in March 2016. There will be two themes.
