Title of Decision:

To approve Community Grants for the Spring 2020 round

Decision made and reasons:

To make grants to the following organisations for the Spring 2020 round of bidding:

- 1. 'Electric Umbrella EUTV' Project: Funding toward the cost of running online music sessions for people with learning disabilities to combat social isolation during the COVID-19 lockdown. £2000
- 2. 'Sunnyside Rural Trust Social Prescribing to Support COVID-19' Project: For the recovery transition period, Sunnyside Rural Trust will build outdoor work benches to enable them to run horticulture courses while maintaining social distancing measures. This will help people to get out of the house again, start to work and build up to group work, rebuild confidence and positive ways of being. It will have a significant impact on their mental and emotional wellbeing. £3000
- **3.** 'Mediation Hertfordshire Virtual Mediation, responding to COVID-19' project: Funding towards the cost of training mediators and Zoom licenses to deliver online mediation sessions and minimise disruption to the service due to lockdown. £3000
- 4. 'Stepping Out Herts Stepping out with Carers' Project: The specific project is to run 4 walks for carers and the people they care for the local area, 3 smaller versions (taking all COVID precautions into account) in Summer/ Autumn 2020 and a full version in spring 2021. These walks will be socially prescribed by the West Herts NHS senior navigator team and their link workers. £2126
- **5.** 'High Street Baptist Church, Tring Baptistry refresh' Project: Funding towards the cost of refurbishing the disused baptistry part of the church, to create a multifunctional space for community groups to use. £3000
- 6. 'Viewpoint Making art and creative connections' Project: Viewpoint is a charity that develops innovative ways that support people with a lived experience of mental health issues and/or addiction challenges. Their project is to offer three weekly art and creative groups (over 12 weeks) for 18 people with mental health challenges and facilitated by people with a lived experience of mental health challenges. Providing a safe place to be creative and discuss issues, share experiences and help to problem solve. £2700
- 7. 'Transitions UK Aspire Dacorum' Project: The Aspire Dacorum Project will support disadvantaged young people (YP), from age 14, at risk of offending/criminal exploitation, building on successful provision in 3 other hubs (Stevenage, Watford Enfield). Transitions UK provide a two-year skills and development programme offering alternatives to offending by providing positive role models (volunteer mentors), personal development opportunities and positive life experiences to

develop a positive life path with attainable goals. This project will support 20 young people over two years. £2000

- 8. 'Herts Inclusive Theatre HIT Hemel Children's and Youth Theatre Project': Herts Inclusive Theatre aims to improve the wellbeing of children and young people and those who are disadvantaged or disabled, by using the arts to build confidence and develop skills in an inclusive, fun, creative space. The project is part of the Herts Year of Culture 2020 and will teach young people to how to perform, use movement, voice work, create artwork, use props, design scenery and learn about putting together performances. £2500
- 9. 'Dacorum Community Dance Let's dance at home' Project: An online digital dance project to keep older adults in Dacorum active, connected, engaged, maintain health and wellbeing and reduce isolation. This project will be part of Herts Year of Culture, meeting its aims by enabling access and participation, celebrating arts and culture in Hertfordshire and increasing wellbeing and a sense of belonging. £1990
- **10.** 'Tring Together Tring Together Christmas Festival goes virtual' Project: The purpose of the project is to change Tring's Christmas Festival into a COVID-19 safe community event. The grant funding will be towards the cost of online marketing and equipment for streaming the event on the internet. £2200
