On DBC as an organisation e.g. on staff or operations	Positive – by using a specialist contractor this will enable the enforcement team to concentrate on more complex and wide ranging environmental crime such as fly tipping, commercial waste, illegal burning and abandoned vehicles. This will provide a sustained high visibility presence to tackle observational offences within the Borough.  Negative – The quality of the service will be closely monitored and any spurious fines issued would be
	quickly addressed. There will be a service level agreement and an officer code of conduct in place to ensure fairness and consistency. There will also be an appeals process for recipients of FPN's, which will be managed and controlled by the authority.

The proposed prohibitions will apply to all demographics and will be enforced appropriately with due regard to any individual characteristics of persons offending/engaged with and the council's overarching public sector equality duty.

What evidence have you used to assess the impact on the community? What baselines have been established and what data will be used to monitor the impact?

Evidence has been gathered from a public consultation into the PSPOs which took place in 2017. Further evidence has been established by complaints received by DBC into the harmful effects caused by littering and breaches of the PSPOs. The decision to enter into a partnership with a private contractor is based on sound research and engagement with other local authorities into options for alternative methods of enforcing against littering, dog fouling and other PSPO breaches. Due process has been followed in regard to this decision and unbiased information and options have been provided. This has been supported by the Chief Officer Group and Corporate Management Team before the decision was made.

What steps have you taken or plan to take to consult the whole community or specific groups affected by the service or policy development?

A public consultation was run in the summer of 2017 and this involved notification by email to specific groups who represent groups who may be affected by the PSPOs. A large number of responses were received to the consultation and although the responses were anonymous responses covered all of the proposed restrictions.

A deliberate and concerted effort will be made to engage with and inform the general public/residents of Dacorum regarding the service by way of public engagement and press releases prior, during and after the contract.
