Introduction

- 1. The previous version of the Medium Term Financial Strategy (MTFS) was approved by Council in September 2014.
- 2. The Budget report to Cabinet and Council in February 2015 provided updated information on the Council's financial position.

Review of the Medium Term Financial Strategy

- 3. In the current economic climate and in light of proposed changes to Local Government Finance it is essential that the MTFS is regularly reviewed to enable forward projections to remain as relevant as possible.
- 4. The attached Strategy has now been reviewed to take into account the pre-audit closure of accounts position for 2014/15, and the Summer Budget 2015.
- 5. It is recommended that Cabinet recommend the revised MTFS to Council for approval. The Strategy will provide the framework for the development of annual budgets for 2016/17, together with the development of the five year Capital Programme for consideration and approval by Council in February 2017.
