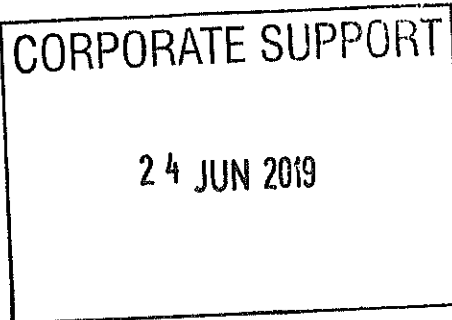





**WARNING:** it may be a criminal offence under section 34 of the Localism Act 2011 if, in relation to disclosable pecuniary interest, you-

- (a) omit information that ought to be given in this notice;
- (b) provide information that is materially false or misleading;
- (c) fail to notify the monitoring officer of changes to your registered disclosable interest after your re-election or reappointment, or when otherwise required under the Act; or

**(d) fail to declare at a meeting a disclosable pecuniary interest that has arisen after the date of this notice and which has not been registered or is not in the process of being registered.**
